

TERMS & CONDITIONS FOR REFERRAL SCHEME



The following terms and conditions will apply to the Motaquote referral scheme.

1. The scheme is open to UK residents only, excluding Northern Ireland
2. This scheme is available through the following branch areas at this time:

3. The scheme is only open to participants who purchase one of the following policies from Motaquote, part of Protectagroup Limited underwritten by various insurers:
 - Private Car (non i-kube)
 - Household
 - Caravan
 - Commercial Vehicle
 - All Small Business Insurance with the exception of Fleet.
4. The referrer will earn a £20 voucher and the person that has been referred (new policy holder) will receive 10% off their policy premium as above.
5. If the new policy is cancelled, the administration fee will not be refunded, as per our standard policy terms and conditions, which will apply.
